

ARTICLES OF INCORPORATION

Of

MINNESOTA MUSIC EDUCATORS ASSOCIATION

We, the undersigned, for the purpose of forming a corporation under and pursuant to the provisions of Chapter 317 Minnesota Statutes, know as the Minnesota Non-Profit Corporation Act, do hereby associate ourselves together as a body corporate and adopt the following Articles of Incorporation:

I.

The name of this Corporation shall be: Minnesota Music Educators Association.

II.

The purpose of this Corporation shall be to develop an appreciation and promote music and encourage cooperation among the various agencies of music education.

III.

No part of the income of the Corporation shall inure to the benefit of any member, trustee, director, officer of the Corporation, or any private individual, except for reimbursement of reasonable expenses incurred. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in any political campaign on behalf of any candidate for public office.

IV.

The period of duration of corporate existence of this Corporation shall be: Perpetual.

V.

The location of the registered office of this Corporation in this state is: 391 Sharon Lane, White Bear Lake, Minnesota, 55110.


